Scope of Services Required:

The selected service provider shall be required to provide the following services:

1. **Transportation:**
 - Suitable tourist bus(es)/Tempo Travellers as per number of trainees and staff.
 - Valid permits, insurance and experienced driver(s).
2. **Accommodation:**
 - Hotel/Guest House accommodation on **triple/quad sharing basis for students and twin sharing for escort teachers.**
 - Each room to be provided with attached bathroom, geyser and basic toiletries
 - Provision for additional rooms/extra beds, if required.
3. **Meals (Vegetarian):**
 - **Breakfast:** Parantha / Poori & Bhaji, Curd, Pickle
 - **Lunch/Dinner:** Paneer dish, Dal Makhani, Mixed Vegetable, Chapati, Rice, Salad and Sweet Dish
 - **Evening Refreshment:** Tea with snacks.
