1. Scope of Work

Supply of **Brass Band and Pipe Band Equipments along with Costumes.**

Proposed Quantity:

1. **Brass Band Equipments** – 1 (One) Complete Set of 33 Items
2. **Pipe Band Equipments** – 2 (two) Complete Set of 33 Items each.
3. **Band Costumes** – - 3 (Two) Different Sets (separate costumes for Boys Band and Girls) of 33 Items each.

The quantity mentioned is purely tentative in nature, and the District Project Officer, Kullu does not provide any guarantee or assurance regarding the issuance of orders in any manner. The actual quantity to be supplied shall be specified in the supply orders issued to the successful bidder.

2. Eligibility Conditions

The bidder shall fulfill the following eligibility criteria:

- All instruments and costumes must be supplied complete with necessary accessories, fittings, and shall carry a **minimum warranty/guarantee** as prescribed.
- The bidder must possess adequate technical capacity, infrastructure, and skilled manpower to execute the supply satisfactorily.
- Non-Blacklisting Declaration

Failure to meet any of the above eligibility conditions shall render the bid liable to rejection.

3. Tender System

5. Submission of Tender

Tenders Tenders duly sealed and superscripted as **"Tender for Supply of Brass Band and Pipe Band Equipments along with Costumes"** shall be submitted in **one sealed outer envelope** containing two separate sealed inner envelopes, clearly marked as **"Technical Bid"** and **"Financial Bid"**, respectively.

The complete tender should reach the **office of the undersigned** on or before the prescribed date and time.

- **Date & Time of Opening of Technical Bid:** 03.03.2026 at 11:30 AM

The Financial Bid of technically qualified bidders only shall be opened separately after detailed scrutiny and evaluation of the Technical Bids.

6. Delivery Period

The successful bidder shall supply the materials **within the stipulated time period** as mentioned in the supply order.

7. Performance Security

The successful bidder shall deposit **Performance Security of Rs. 25,000/- (Rupees Twenty-Five Thousand only)** in the form of Demand Draft/FDR in favour of District Project Officer (SS Kullu District Kullu payable at Kullu HP within the stipulated period after issuance of the supply order. The same shall be refundable after successful completion of the supply and warranty period.



8. Delivery Period

The successful bidder shall supply the complete items **within the period specified in the supply order**, failing which penalty as per Government rules shall be imposed.

9. Vendor Responsibilities

- A. Supply, deliver and install all Brass Band and Pipe Band equipment as per the approved specifications as per Supply order.
- B. Deliver complete sets of boys' and girls' band costumes for both Brass Band and Pipe Band as per Supply order.
- C. Ensure all equipment and costumes meet the required quality, durability, and safety standards.
- D. Train the school staff/band instructors on the handling, basic maintenance and safe usage of the instruments.

10. Sample Submission & Approval

- A. The technically qualified bidder shall be required to **submit samples of** Brass Band instruments, Pipe Band instruments, and band costumes, as specified by the Purchase Committee, prior to placement of the final supply order.
- B. The submitted samples shall be examined and evaluated by subject experts/ Purchase Committee members with regard to quality, workmanship, material, finish, sound output (where applicable), and conformity to approved specifications.
- C. **Only after the samples are approved in writing by the competent authority, the final supply order shall be issued** to the qualified vendor.
- D. In case the sample is **not approved**, the bidder shall be liable to rejection without any claim or compensation.

11. Warranty

- A. All band instruments and related accessories shall have **minimum 2-year warranty**.

- B. Costumes (boys & girls) must be covered under stitching and fabric quality warranty for at least **1 year**.

12. Inspection, Quality Control & Rejection

- A. All Brass Band and Pipe Band equipments and costumes shall be subject to inspection by the Purchase Committee at the time of delivery.
- B. Any item found **substandard, defective, inferior in quality, or not conforming to approved specifications** shall be **rejected outright**.
- C. The competent authority reserves the right to **cancel the supply order wholly or partially** in case of repeated supply of substandard items, without any financial liability.

13. Maintenance & Support

- A. The supplier shall be bound to **replace or repair**, free of cost, any defective or substandard item noticed during inspection or within the **warranty/guarantee period**.
- B. Replacement shall be effected within the time period specified by the Department, failing which suitable action as per procurement rules shall be initiated.

14. Quality Assurance

- A. Quality shall **not be compromised** under any circumstances, irrespective of the estimated cost limits.
- B. All instruments must be new, high-quality, and performance-ready.
- C. Costumes must be stitched with durable fabric, correct size sets, and child-friendly design.
- D. All metallic parts (buckles, badges, cords) must be rust-proof and long-lasting.
- E. All reeds, belts, drums, and pipes must comply with standard band specifications.



15. CRITERIA FOR EVALUATION OF BIDS

- A. The technical/Pre-qualification bids will be opened in the first stage and will be evaluated by the tender opening –cum- evaluation committee so constituted for this purpose in the presence of prospective bidders who wish to be present. No reflection of rates is admissible in Technical Bid. Financial Bid of only those tenderers shall be opened who are found qualified in Technical Bid.
- B. Award of contract will be issued to L-1 Bidder. Separate L-1 shall be selected for each item mentioned in *Annexure –I to Annexure-IV*.

16. **Jurisdiction**

- A. In the event of any **dispute, difference, or legal proceedings** arising out of or in connection with this tender or the supply order issued there under, the **courts at Kullu, Himachal Pradesh, alone shall have exclusive jurisdiction.**


